# Purpose and legal basis of processing - data retention period

<u>Purpose 1:</u> performance of the agreement to which the customer is a party or processing of the customer's pre-contractual requests. <u>Legal basis of the processing</u>: fulfillment of the contractual obligations or performance of pre-contractual activities requested by the data subject. In the absence of such data, the performance of the agreement or the supply of what requested by the customer will be impossible. <u>Data retention period</u>: retention period necessary to fulfill the pre-contractual request or period necessary to perform the agreement.

<u>Purpose 2:</u> activities required by law, including tax, health and safety at work, environment, antimoney laundering, banking and public security law. <u>Legal basis of the processing</u>: need to comply with the law. <u>Data retention period</u>: retention period required by law.

<u>Purpose 3:</u> administrative management of the customers (commercial offers, purchase orders, invoices, delivery notes and other documents related to the contractual relationship possibly containing your personal data). <u>Legal basis of the processing</u>: legitimate interest of the Data Controller in the proper business management, also for the purpose of complying with the law. <u>Data retention period</u>: duration of the contractual relationship with the customer.

<u>Purpose 4:</u> purpose of judicial protection, to prevent or prosecute infringements. <u>Legal basis of the processing</u>: the legitimate interest in protecting our rights and in preventing infringements. <u>Data retention period</u>: it is equal to the period reasonably necessary to enforce our rights from the moment we become aware of the offence or of its potential commission.

## Recipients or possible categories of recipients of personal data:

<u>For one or more of the above mentioned purposes, we may share the data with the following</u> Recipients:

- external consultants
- service suppliers
- Judicial Authority or administrative bodies
- Companies of the group

With the exception of the Judicial Authority and of the administrative bodies, all the said Recipients process the data by virtue of an agreement pursuant to art. 28 GDPR, acting as data processors.

## Rights of the data subject

You have the right to request to the Data Controller, at any time, access to your personal data and a copy thereof, rectification or erasure of the same, restriction of the processing involving your data or to object to their processing, as well as the right to ask the portability of the data, this will not affect the lawfulness of the processing based on the consent given before the revocation.

When you exercise your right of access you have the right to know whether your personal data are being processed, the purpose of the processing, the categories of personal data concerned, the recipients or categories of recipient to whom your personal data are disclosed (and, if they reside in a third country, on the basis of what guarantees), your data retention period (or the criteria used to determine the retention period), whether there is an ongoing automated processing (for example, through the profiling) and the rationale of such processing, the origin of the data (if they are not initially collected by us).
